



Additional Terms and Conditions for the Provision of Legal Assistance to consumers by the Law Firm of Attorney-at-Law Mateusz Hołysz

[Law firm]

I hereby specify additional terms and conditions for the provision of legal services by my law firm at the orders of clients with consumer status. Unless otherwise specified in these terms and conditions, the general terms and conditions for the provision of legal services apply to consumer orders.

[Consumer]

A Consumer is defined as a Client who is a natural person placing an order not directly related to the Client's business or professional activity.

[Order placement]

Your order should include confirmation that it entails an obligation to pay remuneration.

[Cancellation of an order]

You may cancel your order within 14 days without giving any reason. The deadline for cancelling the contract expires 14 days after the date on which the order was placed. To exercise your right to cancel the order, you must inform me of this at the following address: pl. Kościuszki 2, 32-020 Wieliczka, by phone: +48 664 970 021 or by e-mail: kancelaria@holysz.com.pl. You can use the order cancellation form template for this purpose. To meet the deadline for cancelling the order, it is sufficient to send information about exercising your right before the deadline for cancelling the order expires.

[Exclusion of the right to cancel an order]

You may not cancel an order that has already been executed with your express prior consent and you have been informed prior to the execution of the order that in such a case it will not be possible to cancel the order.

[Effects of cancellation]

If you cancel the order, I will refund all payments received from you immediately, and in any case no later than 14 days from the date on which I was informed of your decision to exercise your right to cancel the order. The refund will be made using the same payment methods as those used in the original transaction, unless we agree otherwise. However, if you requested the start of services before the expiry of the order withdrawal period, you should pay a part of the remuneration corresponding to the activities performed so far.

[Starting legal assistance before the deadline for cancellation of the order]

If the provision of legal assistance is to start before the deadline for cancellation of the order, I require you to submit a notice containing such an explicit request and that you acknowledge that you will lose your right to cancel the order once it has been performed.

[No limitation of liability]

My liability for damage caused in the course of my professional activities within the scope of the order entrusted to me by you is not limited to the equivalent of EUR 100 000 as converted into Polish zlotys using the average euro exchange rate announced by the National Bank of Poland for the first time in the year in which the event giving rise to liability occurred.

[Application and amendment of terms and conditions]

These terms and conditions form an integral part of the contract for the provision of legal assistance assigned by the Consumer, if they were delivered to you in writing before the assignment was accepted, or if they were made available to you in electronic form before the assignment was accepted.

In the event of any conflict between the provisions of the contract or the general terms and conditions for the provision of legal assistance and these terms and conditions, the Parties shall be bound by these terms and conditions.

These terms and conditions apply to orders placed on or after 14 November 2025.

These terms and conditions are subject to change and may be updated.

The change is binding on you unless you terminate the order within 14 days of the date of delivery of the amended terms and conditions.
